Cyber Asset Inventory Management (CAIM, commercially known as 'Axonius') is an enterprise product designed to provide a comprehensive view of enterprise asset configurations for operational and cybersecurity purposes. It gathers asset information from various IT tools deployed in the environment and consolidates it into a single dataset. CAIM collects non-sensitive direct identifiers from Microsoft Active Directory (AD), related to user accounts. The types of personal information that is collected includes: Name(s), DoD ID Numbers, Position/Title, Employment Information, Work e-mail Address, and Official Duty Telephone Phone.

d. Why is the PII collected and/or what is the intended use of the PII? (e.g., verification, identification, authentication, data matching, mission-related use, administrative use)

The intended use is authentication and data matching. The data establishes a correlation between user accounts and the authentication services used during the logon process.
